I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to me, and any persons attending the event with me (including minors), including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that I and my heirs and personal representatives and any minors I am responsible for who attend the event with me.

I understand and am aware of the inherent risks associated with equine activities. I assume all risks associated with my participation in the event and hereby release and hold harmless the National Reining Horse Association (NRHA) and the NRBC, and sponsors and suppliers for the event, their respective directors, officers, employees, agents, successors and assigns, from and against any and all claims, damages, liabilities, costs and expenses including reasonable attorney's fees arising out of participation in the event, including without limitation, any personal injuries or damage to my property which I may incur as a result of performing in a reining horse event.

Warning - Under Oklahoma Law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to the Oklahoma Equine Activities Liability Act.

I hereby enter this event at my own risk and subject to all rules and regulations of the NRBC. I am aware of the inherent risks associated with equine activities and I assume all risks associated with the event and hereby release and hold harmless the Built Ford Tough Livestock Complex at Expo Square, the NRHA, the NRBC and all respective directors, officers, agents, successors and assigns, sponsors and suppliers, from and against any and all claims, limitation of injuries or damage to my property which I may incur as a result of my participation or attendance at this event.

I hereby acknowledge that I meet the criteria for eligibility to compete in the classes entered according to current NRHA and NRBC guidelines.
